



SA HUNTERS' PROCEDURE

Dear Hunter,

- To start off your hunting experience with Dovedale Ranch, Botswana, please contact Sumi on whatsapp +27 824906573 to enquire about availability and relevant pricelist.
- After confirmation of availability of your identified weekend a R12500.00 non-refundable deposit is payable to confirm your booking.
- Email proof of payment to info@dovedaleranch.co.bw
- After the deposit is received, we will send you a hunting invitation letter for you to use to apply for meat and rifle permits.

- **RIFLE:**
 - You need to apply at SAPS for your temporary export permit at least 3 months before your hunt. Once the permit has been issued and received share with us a copy on email, we can then assist with the temporary import permit on the Botswana side or you can contact Mohammed on +26771610001 (The temporary import permit on the Botswana side takes approximately one week to be issued)
 - **Note that Stockpoort/Parrshalt is the closest border post to Dovedale Ranch**
 - The following border posts can be used to import/export your rifles:
 - Grobblersbrug/Martinsdrift
 - Stockpoort/Parsshalt
 - Skilpadshek/Pioneer (Lobatse)

- **MEAT:**
 - You need to apply at the department of Agriculture in Pretoria for a meat import Permit. Once this permit has been issued share it on email and we will assist with the meat export permit from the State Vet in Botswana.
 - After your hunt we will accompany you to the department of Wildlife in Machaneng who will issue you an in-trans movement permit.
 - Upon arrival at the chosen border post report to the clearing agents with your invoice for clearing purposes:

- Once your clearing has been done you may proceed to the border. Make sure you have all the necessary documents needed and make sure to inform the clearing agent of the border you will be using.

Borders to use for exporting of meat:

Martinsdrift/Groblersburg

Pioneer/Skilpadshek (Lobatse)

NOTE THAT PARRSHALT/STOCKPOORT CAN NOT BE USED FOR EXPORTING PURPOSES

- The above is also applicable on the export of Trophies/horns/skins

Please note that you have to inform us (Guillaume) if you want to export anything of the above, we also recommend you use a Taxidermy in SA

- We do offer the option of “boud and blad” or to cut your meat form the bone into biltong ect (please see pricelist for costs involved)

- Alternatively, you are more than welcome to make use of Lenice (+26771783090) or Byron’s (+26775911840) services to process your meat. They are situated in Lobatse and arrangements need to be made beforehand.

o We also now offer the services of providing bedding and towels (refer to pricelist for this), please contact us on email to add this service to your hunt.

o We can also provide potable water and ice (refer to pricelist)
